SECTION I - INTRODUCTION

This directory provides a list of MyAdvocate Medicare Advantage GOLD and SILVER HMO-POS network providers. To get detailed information about your health care coverage, please see your *Evidence of Coverage (EOC)*.

You will have to choose a provider to be your Primary Care Provider (PCP). Generally, you will get most of your health care services from your PCP.

The network providers listed in this directory have agreed to provide you with your health care services. Because your plan includes point-of-service (POS) coverage, you may receive covered services from any of our network providers listed in this directory or may choose to use any Medicare-certified provider who has not opted out of Medicare and is located in the United States. If you have been going to one provider, you are not required to continue going to that same provider. For more information on point-of-service coverage, see your *EOC*.

Certain services require prior authorization from MyAdvocate Medicare Advantage. You may be responsible for obtaining prior authorization whether from an in-network or out-of-network provider. The MyAdvocate Medicare Advantage medical director must authorize the service **before** you receive care for the service to be covered by your plan. For more information on services that require prior authorization, see your *EOC*.

There may be times when you get a bill from a provider for the full cost of medical care you have received. In many cases, you should send this bill to us so that we can pay our share of the costs for your covered medical services.

If you have a medical emergency:

- **Get help as quickly as possible.** Call 911 for help or go to the nearest emergency room, hospital or urgent care center. Call for an ambulance if you need it. You do *not* need to get approval or a referral first from your PCP.
- **As soon as possible, make sure that our plan has been told about your emergency.** We need to follow up on your emergency care. You or someone else should call to tell us about your emergency care, usually within 48 hours. Call Customer Service at 888-298-4650 (TTY 711). We are open 8 a.m. to 4:30 p.m. Monday to Friday.

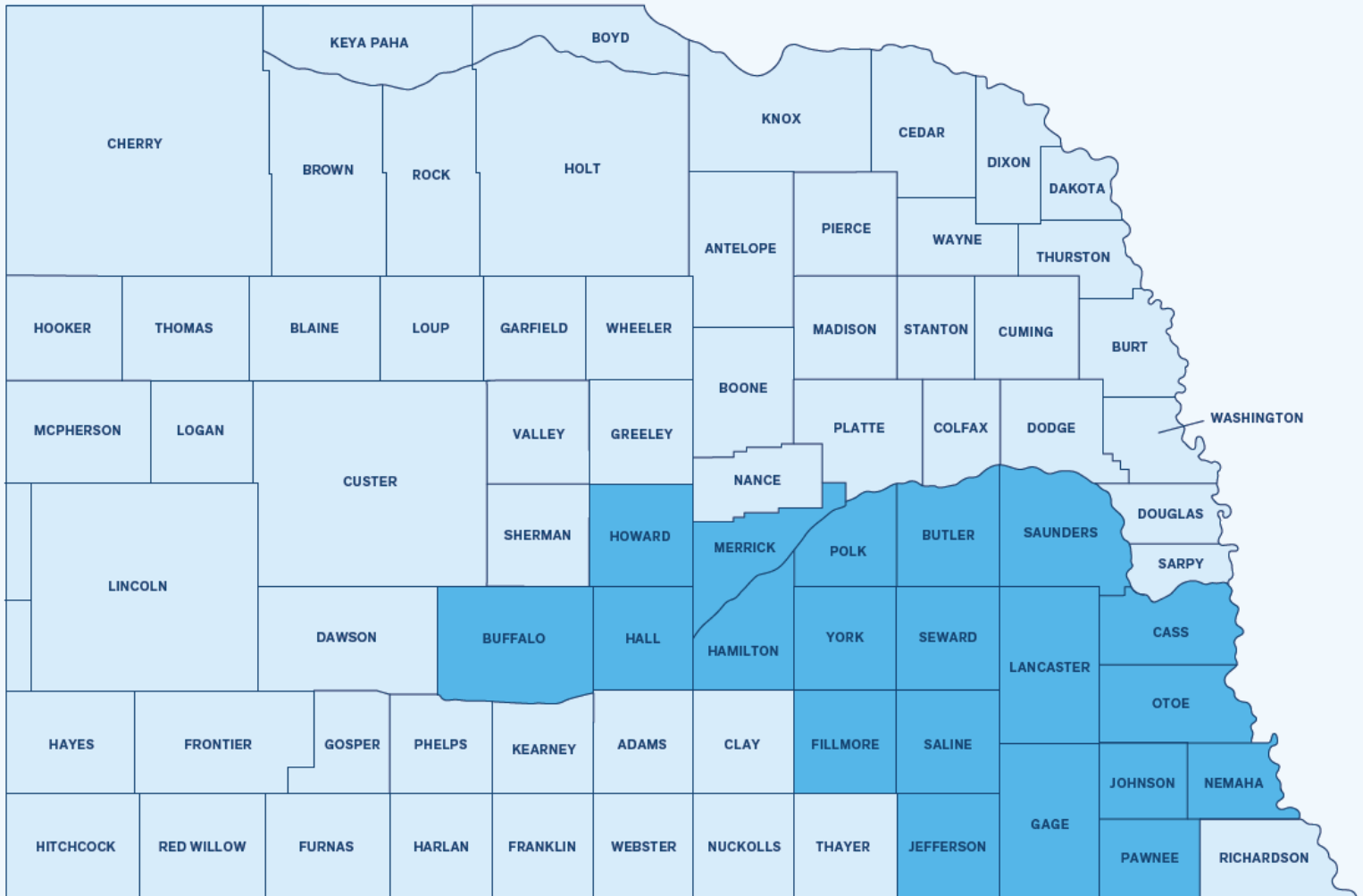
You may get covered urgent and emergent medical care whenever you need it, anywhere in the world. Our plan covers ambulance services in situations where getting to the emergency room in any other way could endanger your health. For more information, see your *EOC*.

If you have an emergency, we will talk with the doctors who are giving you emergency care to help manage and follow up on your care. They will decide when your condition is stable and the medical emergency is over. You are responsible for contacting MyAdvocate Medicare Advantage to notify us of the emergency once your condition has stabilized. Your follow-up post-stabilization care will be covered according to Medicare guidelines.
